He accused the negress and she screamed "murder," which brought Policeman Clay. Later the woman was locked up, but Matron Kirkpatrick could not find the bill. A search was made near where she had met Bright and the bill was found. Recorder Stackhouse committed her to jail in default of \$800 bail.
