

# CAMDEN NOTES

**\*\*** The Union Column Company, capital \$125,000; the Wayne County Development Company, capital \$100,000; the Rio Grande Development Company, capital \$500,000, and the Photographic School Supply Company, capital \$60,000, filed articles of incorporation in the county clerk's office yesterday.

**\*\*** The body of Thomas Hennessy, one of the men killed near Pavoila on February 10, will be interred in New Camden Cemetery to-day.

**\*\*** William Rector, aged 29 years, of 1810 Miller street, while at work in the plant of the Licorice Works at the foot of Jefferson avenue, yesterday, was struck on the head by a falling beam. It is feared his skull is fractured.

**\*\*** Robert Miller, aged 33 years, of 435 Spruce street, fell on the ice in front of his home yesterday and sustained severe lacerations of his face.

**\*\*** The First Ward Young Republican Club will give a smoker at their rooms, Second and Pearl streets, to-morrow night. Prominent speakers will make addresses.

**\*\*** Elmer Normey and Henry Normey, his uncle, of 308 Cleveland terrace, who were found unconscious by William Fields, a grocer, on Thursday, were reported out of danger yesterday by Dr. Vansciver. They narrowly escaped asphyxiation from a leak in the gas pipe in the cellar.

**\*\*** Charles M. Cooper was buried in Harleigh Cemetery yesterday. He was one of the original Cooper family of Camden.

**\*\*** Charles Parker, aged 26 years, of Pittsburg, was found in a semi-conscious condition at Broadway and Pine streets, Camden, yesterday by Policeman Brothers. He was sent to the City Hall, where the officials labored for several hours before he recovered. He claimed to have been given knockout drops in a saloon on North Tenth street, Philadelphia, and robbed of \$50.

**\*\*** The Camden police were notified yesterday that Aaron Smith, aged 30 years, of 807 Sylvan street, is missing from his home, and that fears are entertained for his safety.

**\*\*** Jacob Weller, aged 50 years, of the southwest corner of Fourth and Mechanic streets, Camden, was found dead in bed early yesterday morning. Weller fell four weeks ago and besides a compound fracture of the arm suffered internal injuries. He was only released from the hospital on Friday.

**\*\*** Mrs. Elizabeth Pugh, of 439 Viola street, Camden, tendered a reception to Mrs. Benjamin E. Mellor, Mrs. Thomas Harmon, of Camden, and Mrs. Mary Bakle, of Clactanatt, Friday night, the occasion being the reunion of sisters who had not seen each other for twenty five years.

**\*\*** The prompt action of Recorder Stackhouse, of Camden, yesterday, probably averted what might have been a serious fire at the City Hall. While standing in the corridor he heard a crackling sound in Chief Foster's office. On entering the room he found smoke pouring from the Chief's desk. Hurriedly opening it he found a box of matches on fire. He quickly extinguished the blaze.
