

'CYCLE OFFICER HURT IN SAVING OTHERS

Camden Policeman Runs Machine Into Telegraph Pole to Escape Crashing Into Pedestrians

To avert a collision with an automobile and to save pedestrians from probable injury, Motorcycle Policeman Frank Frost, of Camden, ran his machine into a telegraph pole at Broadway and Mt. Vernon streets yesterday. The machine was damaged, and Frost was hurled into the street. Taken to the Homeopathic Hospital, it was found he had two ribs broken and had been bruised about the body.

Frost was on his way down Broadway when at Mt. Vernon street an automobile suddenly appeared. The officer had no chance of escaping it except by going on the pavement and that was crowded with persons on their way home from Sunday school.

COUPLE HELD AS ELOPERS

Husband Claims Wife Has Married Former Boarder

After a chase of a year in several cities, Pasquale Paolucci, aged 21, and Mrs. Verina Costanso, 17, were arrested yesterday in Camden by Detective Troncone and held pending a hearing before Recorder Stachhouse today on charges made by the woman's husband, Vincenzo Costanso, of 713 Park place, Philadelphia. It was stated that the woman is under a suspended sentence in Philadelphia for bigamy while her alleged companion is under indictment for the same offense.

According to the husband he and his girl-wife were married at Boston in August, 1914. Paolucci was taken in as a boarder and two months later he and Mrs. Costanso disappeared. The husband claims the couple were married at Elkton, Md.
