FINDS WIFE IN ROOM WITH ANOTHER MAN

Detective Who Accompanies Woman's Husband Calmly Awaits Couple After Threat Is Made

When Detective Frank H. Miller went to a closed room in a hotel in Camden early yesterday, a man's voice exclaimed:

"You burst in that door and I'll fill you full of lead."

Miller, who was accompanied by Edward Langley, a Somerdale, N. J., machinist, did not break in the door, but subsequently Frederick Dodd, a plasterer, aged 37 years, of 581 Line street, and Mrs. Catharine Langley, wife of the sleuth's companion, emerged. Both were placed under arrest. At a subsequent hearing before Recorder Stackhouse they were committed to jail in default of \$500 bail on a misdemeanor charge preferred by Langley.

As the woman was being led to the detention room she walked up to her husband and said:

"I am going to make a charge against you," and she was led away after considerable difficulty.
