

Draft Queries Sent Through Mails

The various draft boards in Camden yesterday sent out in the mails the new questionnaire to five per cent. of the registrants who have not yet been called. Each day a like percentage will receive them until all have been supplied. Each contingent will have seven days in which to send their replies. The Legal Advisory Board has organized and designated the time and place where the registrants may obtain the necessary information with respect to filling out the blanks. In the city the boards will sit every night excepting Sunday.

One of the women, armed with a club, followed Brothers for a square while her cohorts howled and shrieked in derisive anger. It was when men were sent to take the coal out of the car that it was found about half had disappeared.

Woman Prefers Jail to Home

Mrs. Eva Stinsky would rather remain in the Camden County Jail than return to her six children on the farm her husband operates at Delair. She is in jail as a result of a misdemeanor charge made against her, together with Frank Siska, of 309 Lemon street. Mrs. Stinsky was asked whether she did not desire to return home and replied that she would rather remain in jail.

Personal Damage Suit

Suit was begun in the Camden Circuit Court yesterday by Frank Dalv, of Gloucester City, against the D. B. Martin Co., of Philadelphia, to recover \$15,000, as compensation for injuries received on November 26. While crossing at Water street and Delaware avenue, Philadelphia, Dalv alleges he was run down by a wagon belonging to the defendant. He had a foot crushed, suffered many cuts and bruises and had a nervous shock.
