

CAMDEN'S OFFICIAL VOTE.

The Judges Compute the Results of the Recent Election—Other Trans-Delaware News.

The Board of Returning Judges met at the City Hall yesterday and canvassed the vote of Tuesday's election. J. Oscar Nichols, of the First ward, acted as chairman. Before the count was commenced, Lawyer Howard Carrow handed in two protests, one was from Jacob Neutze, who was beaten for City Council in the Fourth ward by Dr. William S. Jones, the Republican candidate; the other was from Emil Mettler, the Democratic candidate for Freeholder in the Eighth ward, who was defeated by Henry Sparrow, the Republican candidate. All of those mentioned as elected in the Camden edition of **THE INQUIRER** of Wednesday were returned accordingly.

The vote on Excise Commissioners was as follows: Cherry, 4,468; Fury, 4,313; McDowell, 4,415; Scheimer, 2,944; Kendall, 2,790; Cleary, 2,782; Cowperthwaite, 666; Hatton, 667; Bowden, 660. Kellum was the highest man on the Citizens' ticket, he receiving 2,018 votes. The next board will be composed of Cherry, Fury, McDowell, Republicans, and Scheimer and Kendall, Democrats. Before the board adjourned a protest was presented by Samuel Mowery, the only defeated Republican Councilmanic candidate, against Dr. John W. Donges, of the Eighth ward, taking his seat. Cleary is also going to contest the seat of Kendall, who only defeated him by eight votes. Both men are Democrats.

REPUBLICAN CAUCUS.

The Republican members of City Council who hold over and the newly-elected members held a caucus at the City Hall last night for the purpose of nominating officers who will be elected at the organization of City Council to-day. The candidates for president were Harry M. Snyder, of the Second ward, the present incumbent, and Isaac Githens, of the First ward. Mr. Snyder received the nomination. The other successful candidates are: City Clerk, T. P. Varney, Sixth ward; Assistant City Clerk, William T. G. Young, Jr., Second ward; City Surveyor, Levi Farnham, Ninth ward; City Supervisor, John Blowe, Seventh ward.

LECONY BEFORE THE GRAND JURY.

Chalkley Leconey, who was recently acquitted of murdering his niece, again appeared in the role of a witness yesterday. He went before the grand jury with the object of securing an indictment against Detective Patrick M. Gallagher, of the Prosecutor's office, and Garrett Murray, who was one of the principal witnesses against him in the trial. He based his claim of perjury on the ground that the detective and colored youth had sworn falsely when they testified that the chicken coop had been moved. The grand jury, after hearing the evidence, refused to find a bill. Leconey refused to be interviewed by a reporter, saying that he did not care to talk to newspaper men. The grand jury also refused to find a bill against John Harden, who killed Henry Rawlins in self defense, near Haddonfield, on February 6. Harden was discharged from custody.

BRIEF NOTES.

The Camden City Medical Society, at a meeting last night, decided to appoint a committee to visit the State Legislature and urge the passage of the Kalisch bill, which creates a State Board of Examiners.

Justice Hope, of Stockton township, yesterday committed Elizabeth Murray to jail on the charge of assault and battery on Maggie Harris.

Herman Schaffer gave Constable Tomlin a chase last night. The officer was on the way to the County Jail with Schaffer, who was charged with petty larceny, when he broke away and dashed down the street. He was recaptured and lodged in jail.

Joseph Fenghone was committed to jail by Squire Hope last night on the charge of malicious mischief and assault and battery with intent to kill.
