

OVER THE RIVER.

CAMDEN COURTS.—Yesterday, in the Court of Oyer and Terminer, before Judges Hancock, Tatem and Horner, Sylvester F. Wilson was arraigned for trial on the charge of forging railroad passes and tickets. The prosecution demanded a struck jury, and the case was laid over until to-morrow. John Owens was then put on trial on a charge of arson in setting fire to his own store on Spruce street, near Third, in August last.

COUNTY JAIL.—Justice Soulers yesterday committed Hugh Reiley to the county jail for twenty days for drunken and disorderly conduct. Reiley has been indicted, and was out on bail on Saturday night, and his arrest was the cause of the disturbance in the Seventh Ward at the time Soulers was injured.

MILITARY FUNERAL.—Yesterday morning the body of Major Morris, who died in Nebraska and was brought to Camden, was conveyed to Moorestown under escort from the Sixth Regiment and also from Lodge No 15, A. F. A. M., where he was buried with ceremonies incident to those organizations.

TRIPPING FIRE.—Yesterday morning, about nine o'clock, the floating around the boiler in Vespera Scudder & Co's planing mill, at Front and Federal streets, Camden, was discovered to be in flames. By the prompt use of extinguishers the fire was subdued. The damage was trifling.

KNOCKED DOWN.—While on his way home on Saturday night, and when near Broadway and Ferry road, in the Eighth Ward, James Johnson, colored, was approached by a man who knocked him down, took his basket of marketing and escaped.

UNCONSCIOUS.—Last evening Dr Thomas F. Cullen, a prominent and highly esteemed physician of Camden, was lying in an unconscious condition, and was not expected to survive until this morning.

NIGHT SCHOOLS.—The night schools of Camden commenced last evening for the season with a good attendance. The artisan division was also well filled.

GRAND ARMY OF THE REPUBLIC.—Last evening a deputation of Post No 2 G. A. R., of Philadelphia, paid a friendly visit to Post No. 5, of Camden.

BURGLARY.—The mill of L. D. Woodward, at Cookstown, was entered by burglars a few nights ago and a lot of flour and some money were carried away.
