

Camden Courts—May Term—The May term of the Camden County Courts was opened yesterday by Judge Parker, recently appointed to the circuit in place of Judge Woodhull. The following named persons were selected as grand jurors. Thomas McKeen, James R. Carson, James A. Bray, Andrew Casselman, Edward Delacroix, James Garrison, Jr., Rudolph W. Birdsell, John W. Branning, David B. Kalghn, Daniel Dukeman, B. W. Pierce, Dempsey D. Butler, Joseph H. Hall, William Thompson, Noah Morton, John M. Pettit, Alfred Cramer, Joseph H. Cole, John Gill, Jr., Thomas J. Wentz, Henry Stewart, James Flinn, B. W. Bennett, J. F. Bodine. All were qualified except Garrison, Flinn and Branning, who were not present.

Judge Parker then addressed the jury in quite a lengthy charge, urging them to avoid partisan and sectarian influences, and not to permit any one against whom a decided case had been proved to escape trial. He likewise urged them not to put the innocent in jeopardy, thereby subjecting them to inconvenience of an unjust accusation. The judge recited the early history of Camden, and concluded by admonishing the jurymen to observe the strictest secrecy in regard to important information presented to them, as the premature disclosure of such information might lead to the escape of the guilty. The jury then retired. The usual motions in civil cases were made, and, by direction of the judge, all motions for postponement were made yesterday. It was decided that applications for licenses to keep inns and taverns shall be considered on the 17th instant. The court then adjourned.

Regatta—Recently, at a meeting of the Cooper's Point Yacht Club it was decided to have its introductory regatta on the 17th of the present month. The home boat will be anchored north of the Camden and Atlantic ferry house. Up to the present time the following entries have been made: No. 1, Keenan; No. 2, Fitch, (a new boat); No. 3, Springer; No. 4, Holland; No. 5, Norcross; No. 6, Cahill; No. 7, Phil. Cramer, No. 8, Amy; No. 9, Louis Cramer, No. 10, Schuck, No. 11, Mayberry; No. 12, Undine (new); No. 13, Pieney. These yachts belong to the 16 and 18 feet class, and it is said that about five others will also be entered, of the 15 feet class, but will take positions and sail by themselves. On the same day the South Camden Club contemplate sailing their race.

Drowned Body Found—Yesterday, while Mr. T. Jakes and others were fishing in the Jersey channel, between Camden and Windmill Island, they found the dead body of a man floating in the river. They towed the body ashore and notified Coroner Jeffers, who took it in charge. It had been in the water some time, and from appearances it is supposed to be the body of a young man named Oldfield, aged eighteen years, and who resided on Third, below Bainbridge street, Philadelphia, who had been missing from his home for some time past.

Suicide—Yesterday afternoon a man, whose name is supposed to be L. C. Barstow, and who belongs in Wilkesbarre, Luzerne county, Pa., committed suicide by shooting himself through the head with a revolver, in a field near the Messrs. Browning & Brothers' log wood mills, on Cooper's creek. Deceased was apparently about twenty-eight years of age, and had on his person a gold watch and chain, some small change, and a letter directed to him in a lady's handwriting. The body was taken in charge by Coroner Jeffers, who will hold an inquest to-day.

Judge Parker's Reception.—Last evening ex Governor Parker, now Supreme Court Judge of the Second Judicial District, gave a reception and dinner to the legal fraternity and a number of friends in Camden, to signalize his introduction as the presiding judge at the May term of the court. The occasion was one of much cordial feeling.

Postponed.—Yesterday in the Camden Quarter Sessions the case of the City of Camden against James W. Wroth, ex city treasurer, for embezzling \$12,000, was postponed until the October term.
