

NEWS FROM CAMDEN COUNTY.

A Big Batch of Items Gathered from Across the River.

The residence of Thomas R. Arrison, at No. 224 Kaighn avenue, Camden, resembled a Chinese conservatory last evening. The spacious lawns on both sides of the house were decorated with flags and Chinese lanterns. The occasion was the farewell reception of Rev. Isaac W. Bagley, pastor of the Tabernacle Church, who leaves Camden to-day for Harrisburg, to accept a new charge. Mr. and Mrs. Bagley received from 9 to 10. Among the prominent persons present were: Mayor Pratt and wife, Senator George Pfeiffer, Assemblyman John Harris and wife, J. Henry Hayes and wife, Coroner James G. Stanton and wife, J. Harry Knerr, Judge Thomas McDowell, Thaddeus P. Varney, Rev. E. V. Glover, of Haddonfield, and about 200 other guests.

THAT OVERCROWDED CEMETERY.

The Camden Grand Jury yesterday found a true bill against Dempsey Butler, the proprietor of the colored cemetery on the outskirts of the city and which bears his name. It was there where bodies were discovered a few months ago, only six inches from the surface of the ground.

Councilman McQuaid, of Gloucester City, and his two sons John and James, were also indicted for assault and battery on Councilman Mealey, of the same place.

A QUEER PROCEEDING.

Yesterday he complained to the Sheriff that stock dies, lasts and patterns had been carried away until most of the fixtures are now utterly useless. He also says that Richardson refuses to give him the combination of the safe.

PICKED UP BY THE POLICE.

John McGowan, of Sixth and Cedar, yesterday amused himself by throwing teacups at his wife. Mayor Pratt compelled him to give bail to answer the charge of assault and battery.

John Reed, the accused murderer of John Stevenson, a few weeks ago, and who was captured on Monday night at Cedar Lake, as stated in yesterday's **INQUIRER**, was brought to Camden yesterday, and committed to jail. He is the first man charged with murder to be committed to Camden's new jail.

Emily Van Dyke, a domestic, who robbed John Sheppard, of Eighth and Chestnut streets, of household goods, was held in bail by Justice Colding last night.
