

OVER THE RIVER.

CORONER'S VIEW—WAGON UPSET—PAVING OF STREETS—THE NEW RAILROAD TO GLOUCESTER AND MOUNT EPHRAIM—BOARD OF EDUCATION.

...Yesterday Coroner Armstrong held a view on the body of a colored child, whose parents reside at No 830 Locust street, in the Seventh Ward. The name of the child was John Henry Smith, and its death was from cholera infantum.

...As Mr. Anderson was driving a wagon belonging to Richard Wilson, along Chestnut street yesterday, he narrowly escaped being run over by a train of cars on the West Jersey road. He had driven close to the track, and, seeing he could not cross, stopped his horse within a few feet of the road. As the cars came along the horse became frightened and turned suddenly around. The wagon was upset, and the shaft broken. Mr. Anderson and a small child were thrown out, but neither were much hurt.

...The new railroad from Camden to Mount Ephraim, via Gloucester City, is to be commenced in a few weeks. Nearly all the preliminary arrangements have been made,

and as soon as the ordinance giving the company the right to cross streets, ground will be broken on the north end of it. The road is to be operated by steam. It will be a narrow gauge, and laid on the following survey.—Beginning at Kaighn's Point and running along Front street to Atlantic avenue, out said avenue to Ferry road, thence through private property and recrossing Ferry road at or near the bridge, thence through property and across streets mapped out but not yet opened to Gloucester City. The track will run close to the river all the way to Gloucester. It will be the means of closing up the breach in the meadow banks and much of the lowlands in the lower part of Camden city. It is the intention of this company to have this road in working order in about three months, particularly to Gloucester.

...The owners of property residing on Fourth street, between Line and Kaighn's avenue, have petitioned Councils to have said Fourth street paved. An ordinance has been directed to be drawn in accordance with the petition, providing for doing the work. Point street, between Erie and State streets, is also to be paved; also, Line street, from Newton to Hidden avenues.

...Mayor Gaul yesterday held Freeman Gould, colored, to answer a charge of assault and battery on Dempsey Butler, of the Seventh Ward.

...Robert Ward and George Tyson were locked up last evening in the city jail for a hearing, charged with the larceny of tomatoes from the field of a Mr. Powell, at Cooper's Point.

...The Board of Education of Camden met last evening. In the absence of T. C. Moore Mr. L. B. Newton acted as president pro tem. Joseph C. Delacour, treasurer, made out his report, stating that since last meeting he had received \$6172 98, and expended, for various purposes, \$6293 51; balance on hand, \$179 47. The report was not acted on, no quorum being present. The board then adjourned to Friday evening.
