

# SMASH-UP OCCURS ON WAY TO CAMDEN FIRE

## Victim of Triple Accident Sent to Hospital--One Fireman Breaks Wrist, Heat Overcomes Another

Enroute to a fire which destroyed the big stone barn at Dudley Grange, Deputy Chief Carter's red auto and the First District motor ambulance figured in a triple collision at Fifteenth and Federal streets, which sent one man to Cooper Hospital. In an effort to avoid striking a wagon driven by Harry Green, aged thirty-one years, of 1840 South Eighth street, the ambulance crashed into the chief's machine and hurled the latter car against Green's wagon. Green was thrown from the seat, and at Cooper Hospital was found to have sustained contusions of the head and shoulder and lacerations of the hand. The occupants of the two autos escaped injury but both machines were put out of commission.

The firemen confined the flames to the barn, which was part of the beautiful homestead of Attorney Edward Dudley, who recently figured in stational divorce proceedings. Fireman William B. McCauley had his right wrist broken by a falling timber and Fireman William Rushworth was overcome by the heat. The loss was about \$5000.

### Prison Term for Circus Man

Shown to have served six terms in prison, one a stretch of six years for shooting a man, Jesse Davis, a negro, was yesterday afternoon sentenced by Judge Boyle in Camden to serve from three to seven years for assault and battery on Watson Lybrant, a boy. Davis was an attache of the Barnum & Bailey show. When the show was exhibiting in Camden on May 13 he got in a row and hit young Lybrant on the head with a brick.
