

CAMDEN MAN LOCATES HIS MISSING DAUGHTER

Finds Girl in Providence, Rhode Isl- and—Alleged Abductor Is Un- der Arrest

Vanishing in August last at the same time Joseph J. Cooper, a married man, who was employed by her father as a bartender at his hotel at 625 Perry avenue, disappeared, Miss Mary Miller, aged 17 years, was located yesterday at Providence, Rhode Island, by her father and Policeman Gondolf on information, it is claimed, furnished by Cooper, who was arrested on Thursday when he returned to his home at 640 Central avenue for clothes.

The couple, according to the police, have been living in Providence as Mr. and Mrs. Myers and four months ago the girl gave birth to a little girl. With her infant she was brought to Camden by her father and will be used as a witness against Cooper, who is accused of abduction.

He will be given a hearing today.

Discuss Municipal Finances

Financial methods in vogue in the cities of Camden, Gloucester, Millville and Atlantic City were discussed at length yesterday afternoon at a session in Camden of the Legislative Committee on Survey of Municipal Finance. The meeting was presided over by Arthur N. Pierson, of Union county, chairman of the committee, who explained that the idea was not to probe into city finances, but to have an exchange of ideas with a view of having the Legislature enact a bill for a uniform system of municipal financing. Particular attention was paid yesterday to the sinking fund proposition and the members of the commission expressed themselves as pleased with the information gleaned.

Sons Will Only Get \$5

Judge Boyle yesterday in Camden dismissed a caveat filed against the will of Joseph Dumbroski, who died at his home at Blue Anchor on March 24. The caveat was filed by a son, Joseph Dumbroski, who with his brothers, John and Maximilian, were left \$5 each, the balance of the \$3500 estate going to their mother. The will was drawn by the attending physician two days before death and the allegation was made that undue influence was used. The court said that the evidence did not sustain the objection.

Names Cattle Inspector

In response to a request from the government Mayor Ellis, of Camden, has named Dr Charles B. Helm as cattle inspector. His duty is to inspect all cattle shipped to Camden and his compensation is paid by the cattle owners. The State Board of Health has sent the Mayor a letter approving of his selection.
