

WILL GO TO MANILA.

New Jersey Appointments to New Volunteer Regiments.

ONE HUDSON COUNTY MAN

Although Six Companies to the New Jersey Volunteers Came From This County, the Rest of the State Secured Ten of the Commissioners.

The appointments allotted to New Jersey in the new volunteer regiments to be organized were filled yesterday at Washington by the War Department issuing commissions to the following:

To be Captains—Edmund Dubois, late Major Fourth New Jersey, Forty-second Infantry; Jacob N. Coward, late Captain Fourth New Jersey, Forty-seventh Infantry.

To be First Lieutenants—Terrence Murphy, late First Lieutenant Fourth New Jersey, Forty-sixth Infantry; Theodore Reiser, late Captain First New Jersey, Forty-second Infantry; Harry M. Dey, late Captain Fourth New Jersey, Forty-third Infantry; A. Larue Christie, late Captain Fourth New Jersey, Forty-seventh Infantry; Lorenzo D. Dyer, late Captain Third New Jersey, Forty-seventh Infantry.

To be Second Lieutenants—Harold Swann, late Second Lieutenant Fourth New Jersey, Forty-third Infantry.

Hudson County only secures one appointment, that of A. L. Christie. At present he is Captain of Company I. of Bayonne, Fourth Regiment, National Guard. He has been in the State militia since May 25, 1893. He was elected First Lieutenant of Company B, which he assisted in organizing, two weeks after his muster in with that company. He became Captain of Company I over a year ago and served as Captain of Company I. in the Fourth New Jersey Volunteer Infantry. He is not engaged in any business.

Messrs. Coward and Swan are both from Trenton, and with Clayton J. Bailey, recently chosen by the President for a First Lieutenancy, makes three offices filled from that city. Mr. Coward is an attorney and was recently appointed solicitor to the Board of Health. He has been a well-known militiaman and was one of the prominent members of the Gun Squad in Company A. Mr. Swan is a stepson of A. Judson Rue and is still quite a young man. He has a wide circle of acquaintances, however, and his selection is being generally commended.

Harry M. Dey and L. D. Dyer are residents of Camden. Edmund Dubois is a resident of Woodbury. At present he is a Lieutenant-Colonel of the Third New Jersey Regiment, National Guard, and was formerly Captain of Company E, Woodbury. During the war with Spain he was a Major in the Fourth New Jersey. Dyer is also a member of the Third Regiment, being Captain of Company C. He commanded a company in the Fourth New Jersey during the Spanish war. Dey is a lieutenant in Battery B, and was also an officer in the Fourth Regiment during this conflict.

Local officers who served in the Fourth New Jersey Volunteer Infantry are proud of the fact that so far eleven commissions have been issued for the new volunteer forces to former officers of that regiment. Hudson County furnished six companies for the Fourth and now gets one commission. The other parts of the State sent six companies to the same regiment and secure ten commissions.
